Quick Reference Guide

Applies to:	Island Health patients and families enrolled in and using MyHealth patient portal.
Purpose:	To learn how to view and download clinical documentation in MyHealth.

MyHealth

The MyHealth portal provides patients with access to view certain clinical documents released to their portal accounts. Island Health has approved 12 initial document types that will be available starting April 27, 2022, with more anticipated to be added in the future.

Please note:

- Information viewed or printed from MyHealth represents a point-in-time copy of information available at that time and may not reflect a complete representation of all your results; i.e., the document may be updated after you print it, so please refer to the portal for most up-to-date version.
- Some Island Health clinical documentation may not display, as providers may choose not to
 release their notes to the MyHealth portal. To obtain a copy, follow the Freedom of Information
 process outlined <u>here.</u>
- At this time, MyHealth released clinical documents have a publishing delay of eight (8) hours once they are signed.

Viewing your Clinical Documentation

To view your documents:

1. In the **Dashboard**, click the **Health Record** downward-pointing arrow.

- 2. Select Clinical Documentation.
 - The **Clinical Documentation** window will appear with a list of clinical documents available for your review that will display from most recent to oldest.
- 3. From the document list, click the document title you wish to review. It will open in another tab.
- 4. To view a group of similar documents, click the note type arrow to apply a filter (see screen shot below for the available filters)
- 5. For additional information, refer to the grey box to the right of the screen.
- 6. Click View More at the bottom of the grey box to view the current list of *Note Types* available.
