Incident Reporting Outside of Licensing Hours

Did you know...

A Licensee must notify the medical health officer **within 24 hours** after a child is involved in, or may have been involved in, a reportable incident described in Schedule H while under the care or supervision of the Licensee (CCLR Section 55(2)(a)).

Notification can be done by:

- (a) Phoning your Licensing Officer directly and leaving a message;
- (b) Phoning the general Licensing line and leaving a message;
- (c) Faxing a partially completed incident report to your Licensing Officer;
- (d) Sending an email to your Licensing Officer.

Please note that if you are reporting an allegation of abuse or neglect and your Licensing Officer is not available, please press 0 and ask the Office Administrator to redirect your call to another Licensing Officer.

Update on the Risk Assessment Tool

The Community Care Facilities Licensing Program in Island Health uses a provincial tool used to conduct risk assessments of facilities. A risk assessment is required due to non-compliance posing a risk to children in a facility.

The Risk Assessment Tool is scored out of 40 and will determine the facility's overall risk rating. A facility is categorized as being:

- \Rightarrow High Risk if the score is between 21 and 40. Inspections will occur at least once every 6 months.
- \Rightarrow Medium Risk if the score is between 14 and 20. Inspections will occur at least every 9 months.
- \Rightarrow Low Risk if the score is between 1 and 13. Inspections will occur at least every 12 months

Children's' Record of Immunization - Jamie Crowder, Licensing Officer

One of the most frequently cited sections of legislation in child care settings is in regards to a child's immunization status. Section 57(2)(a) of the Child Care Licensing Regulation states:

A licensee must keep, for each child, a record showing the following information: (a) name, sex, date of birth, medical insurance plan number and immunization status;

It is the Licensee's responsibility to ensure these records are on site prior to the child's first day of care. If parents cannot find, or do not have easy access their child's record of immunization, obtaining a copy is a relatively simple process for any child who was immunized within Island Health.

A parent or guardian can call any Island Health Public Health Office and request a copy of his or her child's record of immunization. A copy can then be made available for pick up at that location, or can be mailed to the parent or guardian. For example, if a child received their immunizations in Victoria, and the family has moved to Nanaimo, the Nanaimo Public Health Unit will be able to access those records and have a copy made available at the Nanaimo location.

If a child has received their immunizations from outside of Island Health, a parent or guardian will need to contact his or her previous doctor or health unit to obtain a copy of those records. If a child has not been immunized, this must also be documented in some way at the facility. If a record of immunization has been recorded by a parent or guardian on the child's registration form, in order to be compliant with legislation, the information must also include the type of each immunization received and the date each immunization was given.
