BE PREPARED TO SHARE APPROVED MEDICAL EXEMPTION DOCUMENTS IF APPLICABLE

## **Proof of vaccination** includes one of the following:

- Electronic proof of BC Vaccine Card with QR Code and name of holder
- Printed copy of BC Vaccine Card with QR Code and name of holder
- Paper proof of vaccination issued by government or vaccination clinic with dates of dose(s) and name of holder

Valid photo ID (age 18+) includes any of the following:

- photo BC Services Card with photo
- Canadian Driver's License with photo
- passport including photo
- certificate of Indian Status
- Métis Nation BC citizenship and ID card

#### **VISITOR INFORMATION**

Effective November 2021, an additional validation step has been added to our screening process for visitors.\*

To enter any Island Health hospital, visitors are now required to show proof of vaccination.

**Exceptions will apply for:** 

- Children under 12 years
- Visitors with <u>approved</u> medical exemption documentation
- Unvaccinated visitors who meet specific care setting criteria

\*In accordance with the Provincial Acute Visitors Policy.



#### **YOUR PRIVACY**

To protect the privacy of all visitors, we do not record vaccination information at our entrances.

As such, visitors may be asked to provide proof of vaccination at every visit.

#### **VISITING GUIDELINES**

#### WHAT VISITORS NEED TO KNOW

#### All patients are eligible for up to two vaccinated visitors at a time.

#### SCREENING PROCESS FOR ALL VISITORS

- 1. We will walk through a list of screening questions for risk of exposure, signs and symptoms of COVID-19 prior to every visit.
- 2. Please provide proof of vaccination and matching photo ID:
  - Visitors with proof of full vaccination may enter the facility
  - Visitors with <u>approved</u> medical exemption documentation may enter the facility
  - Unvaccinated visitors (no doses), or those unable to provide proof, must qualify for an exception prior to entry:
    - Visitors requesting a visit based on the exception guidelines must put on a medical-grade mask and wait for instructions from a unit leader

#### ALL APPROVED VISITORS MUST:

- Clean hands before entering the facility and use hand sanitizer before/during/after their visit.
- Put on a new medical-grade mask (provided) and proceed to the visit location.
- Wear the mask provided in all clinical and nonclinical areas, and do not remove mask to eat or drink at the bedside.
- Respect the personal space of others.

#### **EXCEPTION GUIDELINES**

Care teams will consider all requests for a visit from an **unvaccinated visitor** based on the following exception guidelines:

- Visits as a support person to the Emergency Department
- Visits to the Intensive Care Unit
- Visits for compassionate care (e.g. critical illness and end-of-life)
- Visits for pediatric care, labour and delivery
- Additional exceptions will be considered for spiritual, cultural and/or clinical needs by the care team

#### VISITORS NOT ELIGIBLE FOR EXEMPTION

 If you would like to discuss this decision with a unit/site leader, please wear a medicalgrade mask and wait in the designated area for someone to meet with you.
